PRI reporting is the largest global reporting project on responsible investment. It was developed with investors. for investors.

PRI signatories are required to report publicly on their responsible investment activities each year. In turn, they receive a number of outputs, including a public and private Transparency Report.

The public Transparency Reports, which are produced using signatories' reported information, provide accountability and support signatories to have internal discussions about their practices and to discuss these with their clients, beneficiaries, and other stakeholders.

This public Transparency Report is an export of the signatory's responses to the PRI Reporting Framework during the 2024 reporting period. It includes the signatory's responses to core indicators, as well as responses to plus indicators that the signatory has agreed to make public.

In response to signatory feedback, the PRI has not summarised signatories' responses – the information in this document is presented exactly as it was reported.

For each of the indicators in this document, all options selected by the signatory are presented, including links and qualitative responses. In some indicators, all applicable options are included for additional context.

- Delivered a continuous stream of ESG-related trainings to internal and external stakeholders, including the release of sustainability-oriented training modules from a third party to more than 500 employees throughout Principal.
- Launched new sustainable investment products.



- Aligned select sustainable investment products and engagement strategies to 13 SDGs.
- Formalized our Principal Asset Management Stewardship and Engagement Policy Statement and have been awarded signatory status to the UK and Japan Stewardship Codes.

AUM is representative of Principal Asset Management investment teams as of December 31, 2023.

Assets that are considered sustainable investment products are internally classified by Principal Asset Management and not by any third party or regulatory body.

SDG aligned sustainable investment strategies include our thematic and impact products as well as our Equity ESG Engagement strategy and our Pillar of Responsible Property Investing initiative.

A media company marketed a new sustainability-linked 1st lien loan due 3/2/2031. The sustainability-linked loan has two key performance indicators (KPIs) that can potentially adjust the SOFR margin up or down by 7.5 bps. The first KPI tracks Scope 1 and Scope 2 greenhouse gas (GHG) emissions, and the second KPI tracks non-renewable electricity purchased. The loan credit agreement outlines annual KPI targets through 2031. Failure to achieve targets for both KPIs increases the SOFR margin by 7.5 bps, achieving 1 KPI leaves the margin unchanged, and achieving both KPIs decreases the SOFR margin by 7.5bps. The firm has attractive business qualities including a recurring revenue business model and #1 market position. ESG factors were also a primary consideration as the two sustainability KPIs incentivize the company to lower its GHG emissions and shift its consumption of electricity to renewable sources.
